#### **Items of Business**

ESTABLISH QUORUM: Quorum of Board of Directors established.

WELCOME/CALL TO ORDER: Jason called the meeting to order.

**APPROVAL OF PREVIOUS MEETING MINUTES:** The Board of Directors approved the minutes from the February 16 Budget Ratification Meeting.

**REPORTS:** Kelly gave a report on the current violations in the neighborhood. She will be conducting monthly walkthroughs and will check on 2nd violations after the allotted 10 days. Residents expressed concern over Christmas decorations still up on Delanie. Mr. Quesinberry asked the Board to send a notice of violation to 306 CG for violating Article L, Section 11 by creating an annoyance w/ ongoing music with excessive bass.

Treasurer's Report: Jason read through the financials for the Treasurer's report.

Maintenance report: Ponds are fully functional. Discussion to repair the erosion and maintenance options was tabled until Kevin Wood could be present. It was decided that the board would fill the hole by the Joshua Norman retention pond. The Front Entrance Beautification project was discussed with those committee members in attendance. Residents expressed interest in encouraging improvement of mailboxes and yard appearances. Residents on Robbie Ln were concerned about the amount of mud coming out of the pipe from the farmer's field. Improvements are expected once/if the farmer plants crops this year.

**OLD BUSINESS:** Kelly discussed the anticipated new home construction at the end of Conner Grant. No plans had been submitted to the city of New Bern or the HOA for approval. A certified letter with a copy of the covenants was sent to the developer. There has been no response. The dog waste problem seems to have improved but bagged waste is being thrown into the swamp. Information was requested from the city about signs to place in the common areas. They would be \$35 each.

**NEW BUSINESS:** ELECTION OF OFFICER - The Board elected Kevin Wood to the open officer position of Vice President.

The Board discussed reserve funds. It was decided that formal Reserve Study was not necessary per advice from our property manager. Necessary Reserve Funds will be determined on our own and budgeted for yearly. The option of switching banks to avoid a \$4/month bank fee was discussed.

Board discussed how to move forward with amending Article O, Section 1 in order to minimize lawyer's fees.

Kelly discussed switching the public Facebook group to a private neighborhood only group. Those in attendance liked the idea.

**OPEN FORUM:** Residents wondered if golf carts were allowed in the neighborhood. No other new topics were raised.

### MEETING ADJOURNED: JASON MOTIONED TO ADJOURN, AND KELLY SECONDED THE MOTION AT 9:00 PM. THE MOTION PASSED UNANIMOUSLY.
